Ms. Briggs has served for 15 of her 25+ years in law enforcement as an executive in competitive physical security and law enforcement activities in federal, state and local governments and the private sector.

Ms. Briggs directed all security operations of the company, which at its zenith employed over 650+plus security officers and grossed over \$35 million in annual revenues.

In 1994, Ms. Briggs expanded the capabilities of the ESET by establishing an Engineering and Information Technology Division that provided technology and facility management service for the U.S. Department of Homeland Security (DHS), Department of Defense (DoD), General Services Agencies (GSA), Department of Housing and Urban Development (HUD). Among her many accolades and recognition as the owner of ESET, an African American woman-owned small business, Mrs. Briggs received two Outstanding Awards from the U. S. Small Business Administration (SBA) and was appointed by President Bill Clinton to the President's National Security Telecommunications Advisory Committee, and by the Secretary of Labor to the Minority-Owned Local Small Business Task Force.

As a Law Enforcement Officer with the Capitol Hill Police Department, Ms. Briggs provided unobtrusive protection to high-ranking government officials, including members of the Supreme Court, the U.S. Congress, and their families, as well as visiting heads of state and other dignitaries. She served for a total of ten (10) years as a member of the U.S. Capitol Hill Police Force, becoming the first female African American Sergeant in the history of the Department.
